Project background



Despite the potential of procurement to drive commercial innovation, the challenges remain significant. **Organisations** seeking to adopt innovative solutions encounter numerous barriers, both on the demand and supplier side: lack of proper identification of the challenges and opportunities, risks associated with technological development, lack of incentives, demand fragmentation, etc.

BARRIERS FROM THE DEMAND SIDE

- Poor public demand for innovation vs. traditional solution/services.
- Inadequate management of risks associated with procuring innovations.
- Lack of incentives for the supply of innovative solutions.
- Legal framework complexity.
- Low organisational, commercial and regulatory skills.


BARRIERS FROM THE SUPPLIER SIDE

- Poor understanding of public organizations requirements, constraints and culture.
- Poor understanding of tender specifications (specifications too descriptive or very generalist).
- Management of intellectual property rights.
- Low capacity to commercialise the products developed.
- Low capacity to attract funding for such developments.
